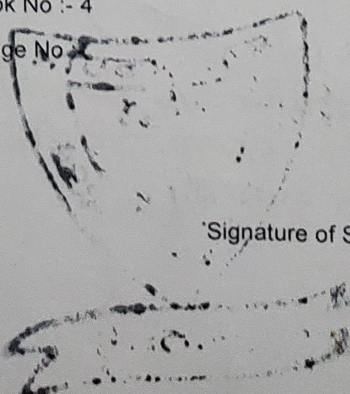


26. DISSOLUTION:



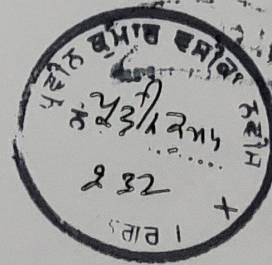

23. **IRREVOCABILITY:**

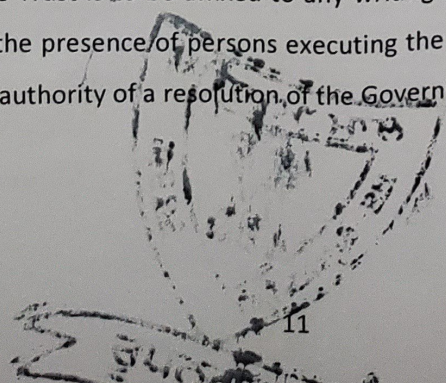

Whenever the seal of the Trust is to be affixed to any writing deed or document executed by the Trust the same shall be affixed in the presence of persons executing the document. The seal of the Trust shall not be affixed except under the authority of a resolution of the Governing Body.

- 20.10 To join, co-operate or amalgamate this trust with other or others having allied objects upon such terms and conditions as the trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.
- 20.11 To make, vary, alter or modify schemes, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and /or running any institution in furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.
- 20.12 To give aid by way of donations out of the income or the corpus of the Trust Fund or otherwise to different charitable institutions, societies organizations or Trust in India which may have been established or which may hereinafter be established for the like charitable purposes.
- 20.13 To grant loan to institutions or persons either on interest or without interest on such terms and conditions as trustees may in their absolute discretion think fit and set apart and/or allocate the whole or a part of the income or the corpus of the Trust Fund.
- 20.14 To apply for grant-in-aid or donation to the Government Departments and Funding Agencies and to accept grants, donations, gifts, subscriptions, affiliation and other assistance with a view to promote the objects of the Trust and to put to any proper condition upon which such grants and other payments may be made.
- 20.15 The Governing Body shall meet as often as necessary but at least once in every calendar quarter at such place and time as the Managing Trustee may decide. He will send the notice and agenda of these meetings to all members of the Governing Body at least fifteen days before the date fixed for the meeting. The quorum for the meeting shall be one third subject to minimum two trustees.
- 20.16 Whenever the Managing Trustee is of the opinion that a special meeting of the Governing Body is to be called to discuss and decide an urgent matter of shorter duration the Managing Trustee and any one of the trustees will form sufficient quorum and they may take necessary decisions on behalf of the Governing Body in such emergency meeting.
- 20.17 The Governing Body shall have the power to determine in case of doubt whether any money or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses to be paid provided that nothing contained shall be deemed to Trustees to spend the income or corpus of the trust for any purpose not authorized by these presents.
- 20.18 To engage or make provision for the engagement of any person (including all or any of the Trustees and committees or administrator or Managing Trustees or otherwise) for the purpose of the administration of the Trust in such rules and regulation as the Trustees may prescribe and also to engage or provide for the engagement.
- 20.19 To borrow moneys either on the security of any property comprised in the Trust Fund or otherwise for all or any of the purpose of these presents and it shall be lawful for the trustee to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.

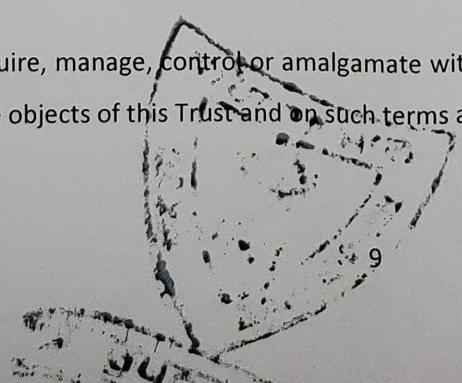

19. TRUST FUND:

- 19.1 That the trust fund may be augmented by the income from the fund and also by donations and other contribution from time to time.

- 19.3 That the Trustees shall always maintain proper books of accounts which shall be kept at the office of the trust.
- 19.4 In the matter of investment of Trust Funds, the provision of section 20 of the Indian Trust Act 1882 shall apply.

20. POWER AND FUNCTION OF THE GOVERNING BODY:

- 20.1 To fill the vacancy created by death or otherwise within three month of the occurrence of such vacancies by appointing any person as trustee.
- 20.2 The Governing Body of the trust will be empowered to open administrative office, Regional office, Branch office and central office of the trust in different states of india.
- 20.3 To administer and control the affairs and funds of the Trust and exercise all power of the Trust in order to carry out the aims and objects of the Trust and manage all the institutions established by the Trust.
- 20.4 To purchase take on lease or in exchange or hire or otherwise acquire any movable or immovable property for the purpose of the Trust and to carry out agreement, loan, grants and other assistance in suitable terms.
- 20.5 To provide grant in-aid and other financial assistance to voluntary organization and work as link between NGO's working in different parts of India and donor agencies and individual donors.
- 20.6 To accept any donation, contribution, grant-in-aid, subscription in cash or in kind from any person, body of persons, trust, foundations, Govt. Departments or Funding agencies with or without conditions.
- 20.7 To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto to, any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- 20.8 To start, abolish, discontinue and restart any charity of charitable institutions for the benefit of general public and to impose any conditions to any subscription or donation made by them.
- 20.9 To take over, acquire, manage, control or amalgamate with any institution having objects either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient.

SECRETARY:

The Secretary shall enjoy all the powers of President in his/her Absence.

- I. Secretary will prepare the Membership Register as well as the Proceeding Register to record the minutes of the proceedings of the Governing Body Meetings and have them duly signed by the members who attend the meetings.
- II. Secretary shall maintain the accounts of all money, which is received and/or paid by him/her on behalf of the trust.
- III. Secretary shall make disbursement in accordance with the direction of Governing Body.

FINANCIAL EXECUTIVE (Treasurer):

- I. Treasurer shall maintain the accounts books and all money, which received and/or paid by him/her on behalf of the trust.
- II. Treasurer shall make disbursement in accordance with the direction of Governing Body.

15. FINANCIAL YEAR:

The financial year of the trust shall be from 1st April to 31st March of every year.

16. POWER TO SUE:

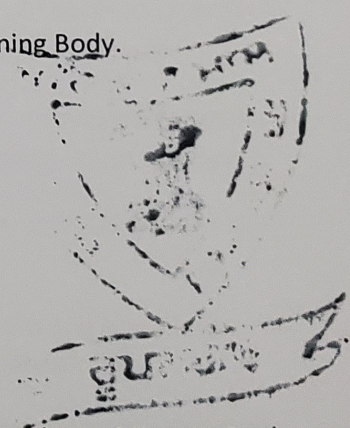

The trust may sue or be sued in the name of the **Managing Trustee**

17. RECORD:

The Governing Body will maintain a record of investments and disbursement besides a Minutes Book recording all resolutions and proceedings for every meeting duly confirmed at next meeting and attested by the Chairman of the next meeting.

18. COMMITTEES:

Trust can permit its beneficiaries to elect committee or committees from among themselves for the smooth and efficient running of any particular branch of its activities. They can form rules and regulations for that particular branch under the given condition.

12.2 OPERATION OF BANK ACCOUNT:

The Governing Body have power to open account in the name of the Trust, with a Bank or Banks, to operate any Governing or private bank such account and to give instructions to the Bank and to provide for opening and operation of such account by one or more of the Trustees or by an agent appointed by the Trustees.

12.3 SETTLEMENT OF ACCOUNT:

The Governing Body will settle all accounts and to compromise, abandon, or refer to arbitration any action or Proceedings or disputes, claim, demand or things, as deemed proper for such purpose without being responsible for any loss occasioned thereby.


13. BRANCH OPEARATION:

Branch can be open in any state of india; no new registration would be required for state branch office.

14. POWERS AND FUNCTION OF OFFICE BEARER:

PRESIDENT:

- I. President shall preside over all the meeting of the trust and have the power to allow inclusion of any subject/matter in agenda for the discussion in the course of proceeding/meeting.
- II. President shall make disbursement in accordance with direction of Governing Body and shall maintain accounts books minute register and manage daily routine correspondence.
- III. At the time of voting on any matter/subject if the total votes of the group of members happen to be equal in number; the President will have casting vote to decide the matter/subject.
- IV. President shall preside over all the meeting of the society.
- V. At the time of voting on any matter/subject (except election) if the total votes of the group of members happen to be equal in number; the Chairman has the power to cast an extra vote to decide the matter/subject.
- VI. President shall have the power to allow inclusion of any subject/matter in agenda for the discussion in the course of proceeding/meeting.
- VII. President shall be convener of all the meetings and without his/her signature on the notice of meetings no meeting will be valid. It shall be his/her duty to see that the resolution at the respective meeting is implemented and given effect timely.
- VIII. President shall be at liberty to append for the purpose of the Society without sanction of the Managing Committee and to do all such other lawful things as incidental or conducive and expedient to the Society.

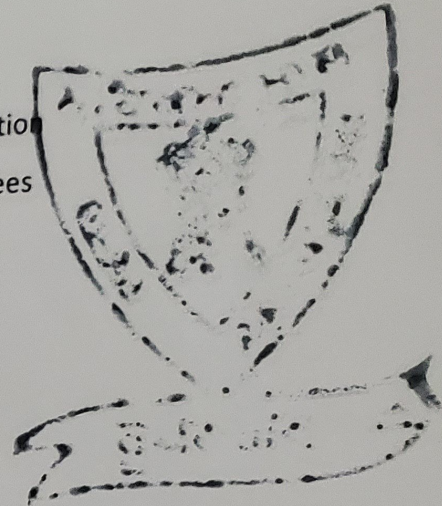
8. TERMINATION OF MEMBERSHIP OF TRUSTEE:

9. Governing Body of the Trust:

The following persons shall form the Governing Body of the Trust.

1. MR. BAHADAR SINGH GILL : President/ Founder
2. MR. HARISH KUMAR : Secretary



10. MANAGING TRUSTEE:

MR. BAHADAR SINGH GILL is designated as the **MANAGING TRUSTEE (Founder/President)** of the trust. He will be at liberty for the time being to appoint additional trustee with in the number mentioned above for such period or on such terms as to retirement and re-appointment as the trustees for the time being consider proper.

11. MEETINGS:

- 11.1 The governing body will be held, at least, once in four months, notice of such meeting being given, at least, 15 days in advance, Decision will be taken as far as possible by consensus and in the event of any difference by majority where the votes are equal; the Chairman will have the casting vote.
- 11.2 The meeting of the Governing body shall be held at such time and place as the Chairman may decide from time to time and all the meeting of the Governing Body shall be presided over by the Chairman and in his absence by any one of the trustees. The annual general meeting shall be held not later than six months after the closing of the financial year.

12. ACCOUNTS:

12.1 Audit of Accounts:

A Chartered Accountant shall audit the accounts of the trust/society every year

7.2 The Trustees will not be entitled to receive any profit, but the Trustees may receive honorarium and reimburse all expenses actually incurred by them in connection with their duties relating to Trust.

7.3 The Trustees shall be accountable only for such moneys, and funds, which will actually come into their hands.

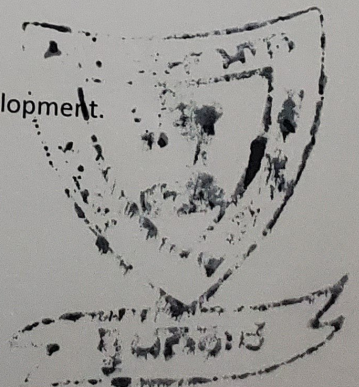

- a. To promote establish, run, develop and manage hospitals, medical colleges, research institutions, counseling centers, dispensaries etc.




Whereas if the trustees desire to co-opt another eminent personality as trustees for betterment of trust, they can co-opt, but the total number of trustee shall not be more than eleven.
